

Deposit and Final Payment: \$300 per person is due at registration. On June 28, 2016 a second deposit of \$500 per person is required for Tours A & B and \$250 per person for Tours C & D. Final payment is due on October 28, 2016. Please make checks payable to Grueninger Music Tours. A \$35 late fee will be charged for payments overdue. No payment reminders will be sent!

Charter Air Deposit: If chosen for charter air, an additional deposit of \$250 per person will be due to confirm your seat. All deposits are non-refundable.

Cancellation Policy: From time of booking to June 28, 2016 there is a 10% cancellation fee per person of trip cost. From June 29, 2016 to October 28, 2016, there is a 25% cancellation fee per person of trip cost. No refunds on or after October 29, 2016. In order to avoid penalties, we strongly suggest purchasing travel insurance (offered through Travel Insured Insurance Services) to cover the non-refundable amount of your tour. This will cover you in the event of an approved accident or illness. Cost of the travel protection plan depends on the cost of the tour purchased. All charter air passenger deposits are non-refundable.
